NOW THIS DEED OF TRUST WITNESSES AS FOLLOWS:

- 1) The name of the Trust, shall be "SAI SEVASHRAM CHARITABLE TRUST, CALICUT".
- 2) The Objects of the Trust are :
  - a) To provide Shelter and care to those persons whom the Trustees feel that there is none to lookafter them.

- b) To provide an "Ashram" for old people to reside therein and to lead a pious Life detached from worldly affairs.
- c) To establish and run health centers, nursing homes and to conduct Medical Camps for Orphans, infirm and invalid children.
- d) To establish Educational Institutions for the poor and needy.

- e) To feed the poor.
  - f) To spread the teachings and messages of Bhagawan Sai Baba of Shirdi, and of Sri Sathya Sai Baba.
  - g) To establish and run Bhajan Mandirs.
- 3) The Trust fund may be augmented by the income from the initial fund and also by donations and other contributions from time to time.
- 4) The Trust fund shall not be applied for any purpose other than those specified in clause 2 above.
- 5) The Trustees shall always maintain proper accounts of the Trust, which shall be kept at the office of the trust.
- 6) In the event of death or resignation of any Trustee, the vacancy thus arose shall be filled up by a nomination jointly made by the remaining Trustees. If the remaining Trustees are not having a unanimous opinion, the majority opinion is to be accepted.
- 7) For the furtherance of the objects of the Trust, the Trustees shall have the following powers :
- a) To accept any donation, contribution, grant or subscription in cash or in kind, from any person (s), body of persons, or trust, with or without conditions.

- b) To open account in the name of the Trust, and to operate the same by any one or more Trustees as decided by the Trustees from time to time.
  - c) To sell, dispose of, alienate or otherwise deal with any property comprising of the Trust Fund.
  - d) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and otherwise for giving effect to the objects of the Trust.
  - e) To take over or amalgamate with any other Charitable Trust, Society, Association or Institution with similar objects.
- 8) In all matters, opinion of the majority of Trustees shall prevail. A Trustee shall be accountable only for such moneys, stocks, or funds as shall actually come into his/her hands. A Trustee shall not be made answerable or accountable for any loss suffered due to the neglect, default, acts, omission or commission by the other Trustees, or of any Banker or other person with whom the Trust properties or securities may have been deposited or kept.
- 9) Trustees are not entitled to receive any remuneration, but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

- 10) Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.
- 11) The Trustees may from time to time frame rules for the conduct and regulations of the administration of the Trust activities and funds, such as :
  - a) The appointment of Manager, Secretary or other staff, and regarding the allotment of work to be done or executed by them.
  - b) The remuneration, salary or honorarium to be paid to such persons.
  - c) The duties and responsibilities of such persons.
  - d) Such other rules which may be necessary for a smooth running of the Trust activities.
- 12) The Office of the Trust shall, for the time being be at KOV-6/356 in Kuruvattur Amson and Desom of Kozhikode Taluk, and shall be liable to be changed by decision made by the Trustees.
- 13) The activities of the Trust shall strictly be in conformity with the Indian Trusts Act 1882.
